SUMMARY OF TESTING METHODS AND KEY FINDINGS FOR REAL WORLD TESTING RESULTS

Medical Office Online electronic prescribing function uses a third party solution (Newcrop, LLC). This function supports the ability to create, change, cancel, refill, receive fill status notifications and request and receive medication history for patients in an internal medicine setting. These functions support the compliance of measure § 170.315(b) Electronic prescribing. For testing, clinicians were asked to perform eprescribe functions based on the certification criteria. Participants were asked to describe their experience and challenges with the functions outlined below. Participants were able to perform most of the functions with ease and had minimal concerns. Challenges during testing included canceling a prescription and processing a change request. Participants found cancelling a prescription to be cumbersome to locate. Participants found the change request to be difficult to process at times. Medical Office Online has reported these finding to our third part vendor Newcrop, LLC. We will continue to follow up quarterly with clinicians and their concerns.

Electronic prescribing enables a user to perform various prescription-related electronic transactions in accordance with the standards outlined in § 170.315(b).
